**4. To cooperate with the previous Deputies Sustainability on the annual assessments.**

**5. To replace the previously accepted collection schedule for the following churches: Belhar, Bethal, Mamelodi and Soshanguve-North and possibly newly instituted churches that will fall within this schedule, with assessments according to the newly adopted differentiated contribution model.**

Assessments have been sent to the churches of Belhar, Mamelodi and Soshanguve-North but no payments have been received up to date.

**6. To pay the deputies the assigned budgets at their request**

Payments have been made and are detailed in the attached financial statements.

**7. To reimburse travel expenses and other expenses made by deputies on their request;**

Payments have been made and are detailed in the attached financial statements.

**8. To reimburse the air travel expenses of classes on their request;**

Payments have been made and are detailed in the attached financial statements.

**9. To submit an interim report for discussion during an Indaba to be held end 2015 or beginning 2016.**

This was done.

**10. To report to the next synod and formulate recommendations according to Article 11 of the Rules of Synod.**

**9.1 Needy Churches (Deputies A11)**

The attached financial statements shows the financial result and position for 2014, 2015 and 2016.

The report by the deputies should outline the financial requirements going forward.

R1,916,532 (94%) of the total funds of R2,039,104 at 31/12/2016 in the care of the questor belongs to the Deputies for Needy Churches.

**9.2 Needy Theological Students (Deputies A19)**

The attached financial statements shows the financial result and position for 2014.

From 1/1/2014 the deputies A19 combined their activities with Deputies Curators for Theological Training and at the same time, they also took over the responsibility for their own financial affairs. This includes handling their own assessments and facilitating the receiving of contributions directly from the congregations. The balance of funds belonging to these deputies were paid to them, therefore the questor no longer has anything to do with the finances of these deputies.

**9.3 Inter-denominational costs**

The attached financial statements shows the financial result and position for 2014, 2015 and 2016.

After two years of shortages (2015: -R14,601 and 2014: -36,632), the year 2016 recorded an excess of R8,494.

R122,571 (6%) of the total funds of R2,039,104 at 31/12/2016 the care of the questor belongs to church bond for inter-denomination costs such as travelling and the costs of hosting synods and classes meetings.

The cost of the synod for 2017 is estimated to be around R50,000 excluding travelling costs.

Despite this, I see no need to request an increase in the contributions from the churches over the next three years, due to the balance in hand.

#### **9.4 Availability of Ernst van Vondel**

I have indicated to the secretary that, after 10 years on the job, I am not available for another nomination as synod questor. I trust that the Lord will provide someone with the skills to take over from me. I would like to take this opportunity to thank all the congregations and deputies for making it a pleasure to fulfil my duties. Also in these things the love of Christ and the working of the Spirit is evident.
